- h. 20 days programme was organized.

## 5. FINDINGS:

The major findings of training programme.

a. The responses received from the M.Ed. (Learner) by pretest were analyzed in the light their knowledge about preparation of Unit plan, use of multi -media and power- point presentation.

b. Majority of teacher educators (94%) did not know how to prepare did not know how to prepare and only 6% teacher educators knew it.

- c. It was observed that more than 90% M.Ed. learner know about the Preparation of unit plan.
- d. 100% of M.Ed. learner agreed about the importance of use of multi-Media in classroom teaching.

e. Majority of M.Ed. learner agreed that they were comfortable while Accessing computer, thus we can say teacher educator at large are comfortable while using the computers -80% of the respondents prepared lesson plan with the help of multi-Media, this shows that teacher educator were able to prepare the lesson plan for B.Ed. class with the help power- point presentations.
