# MAJOR CHALLENGES AND ISSUES IN POLITICAL EMPOWERMENT OF WOMEN Major challenges and issues are listed below.

- 1. Low representation of women In politics: It is an international issue out of 189 countries only 18 countries have depicted more than 30 percent of women representation in their parliaments. Thirty countries provided representation for women between 20 to 30 percent. 64 countries between 10 to 20 percent and remaining less than 10 percent among them india is one of the country ranking 104(worlds ranking) with 8.3 percent representation of women in loksabha.
- **2. Biologically Determined social roles:** Given the socio biological development the biological differences which are real are mis-appropriated made the determining factor in the social placements of male and females. Women are domesticated merely to bearing and rearing children and performing household chores.
- **3. Caste, creed and religion are lacking empowerment women in politics:** Every country has different caste, creeds and religious system. Every women member of the family has to follow this system. Though women are very interested in politics due to this system restrict women not enter into politics, sexual harassment to be questioned.
- **4. Low rate education :** Education place very important role of women in empowerment in politics with in a family girls and boys are to be discriminated in quality of education. Most of girls not be sent local, regional, out of responsibilities at the cost of not learning productive skills. Adult women education not be promoted. Women are not to be educated to acquire political and productive skills.
- **5. Economic injustice:** Women's work within the household to be socially valued. Their contribution to subsistence work not be recognized. Women are treated to be not productive earners. Women are not individually and collectively encouraged to take loans from bank and set up incoming generating ventures. Women exploitation at the work place the husband become more assertive in controlling even their wives ancestral property since development and control of land done by them. Many families are not allowed to work and hold jobs out of stations.
- **6. Ill-health:** Women may be given inferior intake Differential maternal care for men and women. Medical attention may be delayed in case of females Early marriage one of the cause for ill health. Differential asses to food and medical care for women. Emotional and physical abuse of females. Sometimes women are women's worst enemies.
- **7. Shift in the approach needed:** Globalization has presented new challenges for the realization of the goal of the women's equality, the gender impact for the reframing policies for asses to employment, quality of employment and participation in politics.

#### **FINDINGS**

Today every country trying to formulated a number of specific policies and programs for the welfare and participation of women in politics. These plans and programs represent the aspiration of women and use of plans and programs will significant impact on the attitude of women towards public affairs. In India also a number of policies and programs formulated for the development of women.

1. Awareness to constitution rights: These rights are already granted to every citizen of India. In women context

these become important since women largely unaware of these rights and are unable to exercise or demand them. The state aims is to ensure, equality and justice to all citizens. The constitution informs the citizens about their rights and duties. These rights are protected by law

- e.Cultural and educational rights

The 73rd and 74thamendments to constitution provides that women from 1/3 of all representation in local bodies. This is mandatory for women to exercise their rights as paunches and municipal member's women by organizing themselves and forming groups can these provisions of the constitution a reality.

- **2. Organizing Women:** It is the group which can identify group needs, preferences, identity their concerns to evolve a strategy to raise their conditions initiating intervention through nodal groups such as Panchayats, MahilaMandal teachers, etc.
- **3. Dove Tailing:** Women participation and representation in political appears may be difficult to achieve in an outright manner. It may be easier to encourage this by dove tailing issues of women concerns.
- 4. Human Rights Information Act: This act advocates certain issues about women which are listed below.
- a. It gives information about awareness and knowledge about property rights of women.
- b. To raise the information level of participants about various laws governing marriage and Dowry prohibition Act, etc.
- c. To appraise them of the need for the social acceptability of women's rights to property.
- **5. Gender Sensitization of the Community:** Government has provided medical facilities, education facilities, employment and tax benefits for the development of the women.

#### **SUGGESTIONS**

Representation and political participation constitute a major component of political empowerment of women to understand this we have examined the state of representation in the legislators of various countries and legislative body in India and national plans, policies and programs. In order to make women in participation in politics more meaningful, we suggest the following measures.

- 1. Implementation of free and compulsory education for girls.

- 3. Media should reflect respectful image of women.
- 4. Women should have self-awareness about their status, rights and position.
- 5. Effective legislation should be provided for women at their workplace.
- 6. Reservation of seats for women in legislation through legal constitutional provisions till the purpose is served

- 8. Effective implementation of national policies and programs for the welfare of the women
- 9. To setup committees for theoretical evaluation of national policies, programs, workshops and seminars, etc to create awareness and upgrade knowledge of women through voluntary organizations.
