- It is concluded that, the highest i.e. 2333.27 Hect (41.13%) area developed by T.T.C. Industrial Area and the Lowest i.e. 4.27 Hect. (0.08%) area developed by Additional Kalyan Bhiwandi Industrial Area.
- It is concluded that, the highest i.e. 71588 (68.64%) plots are in Tarapur Industrial Area and the Lowest i.e. 2 (0.002%) plots are in Additional Kalyan Bhiwandi Industrial Area.
- It is concluded that, the highest i.e. 70109 (69.38%) plots are allotted in Tarapur Industrial Area and the Lowest i.e. 2 (0.002%) plots are allotted in Additional Kalyan Bhiwandi Industrial Area.
- It is concluded that, the highest i.e. 1553 (47.99%) vacant plots are in Dombivli Industrial Area. Whereas Mira, Additional Ambernath Village Pale & Bhonoli, Kalyan Bhiwandi and Additional Kalyan Bhiwandi (Bhiwandi) Industrial Area has no vacant plots.
- It is concluded that, the highest i.e. 2812 (33.28%) units are in T.T.C. Industrial Area and the Lowest i.e. 20 (0.24%) units are in Kalyan Bhiwandi Industrial Area (Bhiwandi). As such Additional Ambernath Village Pale & Bhonoli and Additional Kalyan Bhiwandi (Bhiwandi) industrial areas have no units in production.
- It is concluded that,, out of total units in Thane district the highest i.e. 59.72% are micro units whereas, the lowest i.e. 0.67% are medium units.
- It is concluded that,, out of total employment generated by industrial units in Thane district the highest i.e. 59.72% employment generated by micro units whereas, the lowest i.e. 4.94% employment generated by medium units.
- It is concluded that,, out of total employment generated by industrial units in Thane district the highest i.e. 59.72% employment generated by micro units whereas, the lowest i.e. 4.94% employment generated by medium units.
- It is concluded that,, out of total investment made by industrial units in Thane district the highest i.e. 47.31% investment made by large units whereas, the lowest i.e. 4.59% investment made by medium units
- It is concluded that,, out of total capacity of production of industrial units in Thane district the highest i.e. 69.10% capacity of production of large units whereas, the lowest i.e. 0.07% capacity of production of medium units.
