ABSTRACT

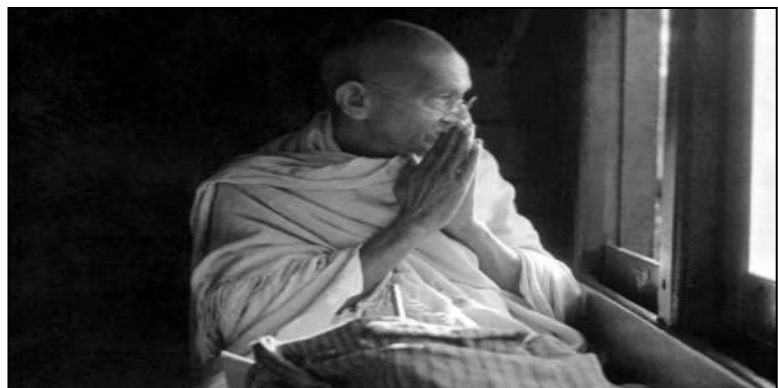
